# A BY-LAW TO AMEND TRAFFIC BY-LAW 78-2005 WITH RESPECT TO PARKING RESTRICTIONS IN THE REBECCA HILLS SUBDIVISION (Joshua Road, Marshall Crescent, Jay Crescent, Murray Court) 

WHEREAS the Municipal Act, 2001, S.O. 2001, c.25, S. 11 authorizes a municipality to pass bylaws respecting matters within the jurisdiction of highways, including parking and traffic on highways;

AND WHEREAS the Council of the Corporation of the Town of Orangeville deems it expedient to amend By-law No. 78-2005, as amended.

BE IT THEREFORE ENACTED by the municipal council of the Corporation of the Town of Orangeville as follows:

1. THAT Schedule " $A$ " (parking restrictions) of By-law 78-2005, be amended by adding the following:
