By-law Number 2026-045

A by-law to amend Administrative Penalty System By-law 2025-049 respecting the service of Penalty Notices and Schedule "B-11" for the Sign By-law

Whereas the Council of the Corporation of the Town of Orangeville enacted By-law 2025-049 to establish a system of administrative penalties; and

Whereas Council has enacted a new sign by-law within the Town of Orangeville and deems it necessary and desirable to amend the Administrative Penalty System By-law 2025-049 respecting the updated Sign By-law;

Now therefore be it resolved that Council for The Corporation of the Town of Orangeville hereby enacts as follows:

1. That the Administrative Penalty System By-law 2025-049 is hereby amended in the following manner:
 - 1.1. That Section 7.2 of By-law 2025-049 is amended by adding the following subsection immediately after subsection (c):
"d) Posting in a conspicuous place on a building or structure located on the property where the contravention occurred, as soon as reasonably practicable after the contravention."
 - 1.2. That Schedule "B-11" of By-law 2025-049 is repealed and replaced with the Schedule "B-11" attached hereto as Schedule "A" which forms part of this By-law.
2. That all other provisions of Administrative Penalty System By-law 2025-049, as amended, shall remain in full force and effect.

This bylaw shall come into effect upon approval by the Council, subject to section 284.11 of the Municipal Act.
