#### By-law Number 2025-051

# A By-law to Amend and Designate By-Laws to be subject to the Administrative Penalties By-Law 2025-049

**WHEREAS** sections 8, 9, and 11 of the *Municipal Act 2001, S.O. 2001, c 25*, as amended ("*Municipal Act, 2001*") authorize the Corporation of the Town of Orangeville to pass bylaws necessary or desirable for municipal purposes; and

**WHEREAS** section 102.1 of the *Municipal Act* and O. Reg.333/07, as amended, authorize municipalities to establish an administrative penalty system requiring a person to pay an administrative penalty for a contravention of any designated by-law respecting the parking, standing or stopping of vehicles; and

**WHEREAS** section 434.1 of the *Municipal Act* authorizes the Town to require a person, subject to such conditions as the municipality considers appropriate, to pay an Administrative Penalty if the municipality is satisfied the person has failed to comply with a by-law of the Town; and

**WHEREAS** section 15.4.1 of the *Building Code Act*, 1992, S.O., c.23 ("Building Code Act, 1992") authorizes a municipality to require a person, subject to such conditions as the municipality considers appropriate to pay an administrative penalty if the municipality is satisfied that the person has failed to comply with a by-law passed under section 15.1 of the *Building Code Act* or an order made under section 15.2(2) of the *Building Code Act*; and

WHEREAS the Corporation of the Town of Orangeville considers it desirable to designate certain by-laws or parts of such by-laws to which administrative penalties under section 434.1 of the Municipal Act and section 15.4.1 of the Building Code Act shall apply; and

WHEREAS The Corporation of the Town of Orangeville considers it desirable to amend such designated by-laws to provide for the application of administrative penalties under section 434.1 of the Municipal Act and section 15.4.1 of the Building Code Act;

Now therefore be it resolved that Council for The Corporation of the Town of Orangeville hereby enacts as follows:

## 1. That Boulevard Maintenance by-law 2019-014 be amended by:

1.1. Adding the following definition in section 1: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town, being By-law 2025-049 as amended from time to time, or any successor thereof;"

- 1.2. Adding a new section as section 7.4: "That sections 2, 5.1, and 5.2 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 1.3. Adding a new section as section 7.5: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 2. That Driving School Instruction By-law 2017-024 be amended by:

- 2.1. Adding the following definition in section 1 "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town, being By-law 2025-049 as amended from time to time, or any successor thereof;"
- 2.2. Adding a new section as section 5.3: "That sections 2, 3.1, and 4.1 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 2.3. Adding a new section as section 5.4: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 3. That Site Alteration By-law 2024-001 be amended by:

- 3.1. Adding the following definition in section 2 "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town, being By-law 2025-049 as amended from time to time, or any successor thereof;"
- 3.2. Adding a new section as section 12.7: "That sections 3, 6.6, 8 and 9, are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 3.3. Adding a new section as section 12.8: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 4. That Idling Control by-law 2007-074 be amended by:

- 4.1. Adding the following definition in section 2.1 "Administrative Penalty Bylaw" means the Administrative Penalty Bylaw of the Town, being Bylaw 2025-049 as amended from time to time, or any successor thereof;"
- 4.2. Adding a new section as section 6.2: "That sections 3 and 5 are hereby designated as parts of this By-law to which the Administrative Penalty Bylaw applies."
- 4.3. Adding a new section as section 6.3: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an

administrative penalty and any applicable administrative fees."

## 5. That Littering by-law 1999-056 be amended by:

- 5.1. Renumbering sections 3 & 4 as sections 5 & 6.
- 5.2. Adding a new section as section 3: "That section 1 is hereby designated as a part of this By-law to which the Administrative Penalty By-law being By-law 2025-049 as amended from time to time, or any successor thereof applies."
- 5.3. Adding a new section as section 4: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 6. That Noise-by-law 2024-023 be amended by:

- 6.1. Adding the following definition in section 1.1 "Administrative Penalty Bylaw" means the Administrative Penalty By-law of the Town, being By-law 2025-049 as amended from time to time, or any successor thereof;"
- 6.2. That Section 8 be renamed from reserved to "Administrative Penalties"
- 6.3. Adding a new section as section 8.1: "That sections 3, 4, 7.1, 7.2, 7.3 and 7.6 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 6.4. Adding a new section as section 8.2: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 7. That Parks & Events By-law 2023-021 be amended by:

- 7.1. Adding the following definition in section 1.1: "Administrative Penalty Bylaw" means the Administrative Penalty Bylaw of the Town, being Bylaw 2025-049 as amended from time to time, or any successor thereof;"
- 7.2. Adding a new section as section 28.13: "That sections 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 18, 28.1, 28.2, 28.6 and 28.9 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 7.3. Adding a new section as section 28.14: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 8. That Property Standards By-law 2022-021 be amended by:

8.1. Adding the following definition to section 2.1: "Administrative Penalty Bylaw" means the Administrative Penalty Bylaw of the Town, being Bylaw

- 2025-049as amended from time to time, or any successor thereof;"
- 8.2. Adding a new section as section 44.2: "That sections 44.1 and 45.1 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 8.3. Adding a new section as section 44.3: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 9. That Sale of Goods/Service From Highways 2007-073 be amended by:

- 9.1. Adding a definition to section 1: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town, being By-law 2025-049 as amended from time to time, or any successor thereof;
- 9.2. Renumbering section 5 to section 6;
- 9.3. Adding a new section 5: Penalty
- 9.4. Adding a new section 5.1: "That section 2 is hereby designated as a part of this By-law to which the Administrative Penalty By-law applies."
- 9.5. Adding a new section 5.2: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 10. That Sign-by-law 2013-028 be amended by:

- 10.1. Changing the current numbering of 3.1 to 3.0.
- 10.2. Adding a new section 3.1 definition: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town, as amended from time to time, or any successor thereof;"
- 10.3. Changing the numbering of current section 10.2 to 10.2 (a).
- 10.4. Adding a new section 10.2 (b): "That section 4 is hereby designated as a part of this By-law to which the Administrative Penalty By-law applies."
- 10.5. Adding a new section 10.2 (c): "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 11. That Vehicle for Hire By-law 2022-038 be amended by:

11.1. Adding a new definition in section 1.1: "Administrative Penalty Bylaw" means the Administrative Penalty By-law of the Town being By-law 2025-049, as amended from time to time, or any successor thereof:

- 11.2. Adding a new section 16.15: "sections 3, 16.8 and 16.11 is hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 11.3. Adding a new section 16.16: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 12. That Fireworks By-law 2004-115 be amended by:

- 12.1. Adding a new definition in section 2.1: "Administrative Penalty Bylaw" means the Administrative Penalty Bylaw of the Town being Bylaw 2025-049, as amended from time to time, or any successor thereof;
- 12.2. Adding a new section 11.7: "section 3 is hereby designated as a part of this By-law to which the Administrative Penalty By-law applies."
- 12.3. Adding a new section 11.8: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 13. That Kite Fighting By-law 2024-063 be amended by:

- 13.1. Adding a new definition in section 1.1: "Administrative Penalty Bylaw" means the Administrative Penalty By-law of the Town being By-law 2025-049, as amended from time to time, or any successor thereof;
- 13.2. Adding a new section 7.6: "section 3 is hereby designated as a part of this By-law to which the Administrative Penalty By-law applies."
- 13.3. Adding a new section 7.7: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 14. That Restaurant By-law 2023-093 be amended by:

- 14.1. Adding a new definition under section 1.1: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town being By-law 2025-049, as amended from time to time, or any successor thereof;
- 14.2. Adding a new section 15.15: "sections 3, 15.8 and 15.1 are hereby designated as parts of this By-law to which the Administrative Penalty Bylaw applies."
- 14.3. Adding a new section 15.16: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

## 15. That Traffic By-law 78-2005 be amended by:

- 15.1. Adding a new definition in section 1: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town being By-law 2025-049, as amended from time to time, or any successor thereof;
- 15.2. Adding a new section 11.13: "sections 3, 4, 5.1, and 9.4 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies."
- 15.3. Adding a new section 11.14: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 16. That Fire Route By-law 2019-011 be amended by:

- 16.1. "Adding a new definition in section 1: "Administrative Penalty By-law" means the Administrative Penalty By-law of the Town being By-law 2025-049, as amended from time to time, or any successor thereof;
- 16.2. Adding a new section 7.5: "section 5.1 is hereby designated as a part of this By-law to which the Administrative Penalty By-law applies."
- 16.3. Adding a new section 7.6: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees."

#### 17. That Animal Control By-law 2024-026 be amended by:

- 17.1. Adding a new definition in section 1.1: "Administrative Penalty Bylaw" means the Administrative Penalty Bylaw of the Town being Bylaw 2025-049, as amended from time to time, or any successor thereof;
- 17.2. Adding a new section 19.7: "This by-law is hereby designated as a By-law to which the Administrative Penalty By-law applies."
- 17.3. Adding a new section 19.8: "Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty

This by-law shall come into effect upon approval by the Council, subject to section 284.11 of the Municipal Act.
