



The Corporation of the Town of Orangeville

By-law Number 2020-022

A by-law to amend By-law 119-2004 being a by-law to licence, regulate and govern taxicabs and taxicab owners, taxicab brokers, limousine owners and limousine drivers and for limiting the number of taxicab owner licences

Whereas By-law 119-2004, as amended, licences, regulates and governs taxicabs and taxicab owners, taxicab brokers, limousine owners and limousine drivers and limits the number of taxicab owner licences;

And Whereas Council considered Report CPS-CL-2020-007 on March 9, 2020 and passed a resolution to amend the current provisions of By-law 119-2004;

Now therefore be it resolved that Council of The Corporation of the Town of Orangeville hereby enacts as follows:

1. That the following be deleted:
 - (a) the definition of "waiting list" and "non resident";
 - (b) Sections 6.1.7, 7.1, 7.2, 7.3, 8.2.14, 9.1, 9.2, 9.2.1, 9.2.2, 9.3, 9.4, 9.5, 9.6, 9.7, 9.7.1, 9.7.2, 9.7.3, 9.7.4, 9.7.5, 9.7.6, 9.8, 9.9, 13.2, 13.3, 13.4, 13.5, 13.5.1, 13.5.2, 13.5.3, 13.5.4, 13.5.5, 14.1.11, 14.2.5 and 14.2.6.
2. That Section 10.1 be amended by deleting "July" and replacing it with "October".
3. That Section 13.1 be deleted and replaced with the following:

"13.1 No taxicab broker's licence, taxicab owner's or limousine owner's vehicle licence shall be transferred without fifteen (15) days prior notification to the Licensing Officer and consent of the Licensing Officer. The Licensing Officer may require the production of any documents and fees regarding the proposed transfer."
4. That the following be deleted from Section 14.1.6:



"- For a taxicab only, an illuminated electric sign, securely affixed on the top of the taxicab, indicating that the vehicle is a taxicab, and the name of the fleet in which it operates. Such sign shall be connected to the meter so as to be illuminated between dusk and dawn when the vehicle is not engaged."
5. That Sections 8.2.9, 8.2.11, 16.1.1 and 16.1.2 be deleted.
6. That Section 8.4.4 be deleted and replaced with the following:

"Provide to the satisfaction of the Licensing Officer proof:

- (a) of a system capable of receiving and dispatching calls for the taxicabs operating within the licensee's fleet;
- (b) that the premises from which the taxicab broker intends to operate is a permitted use in accordance with the zoning by-law of the applicable municipality.

7. That Schedule B be amended to add after "Drop Rate" and "Each kilometer" the word "Maximum".

Read three times and finally passed this 20th day of April, 2020.
