By-law Number 073-2016

A by-law to amend Traffic by-law 78-2005 with respect to parking restrictions.

Whereas the Municipal Act, S.O. 2001, c.25, S.11, authorizes a municipality to pass by-laws respecting matters within the jurisdiction of highways including traffic and parking on highways;

And whereas Council deems it expedient to amend By-law No. 78-2005, as amended;

Be it therefore enacted by the municipal Council of The Corporation of the Town of Orangeville as follows:

1. That Schedule "A" (parking restrictions) of By-law 78-2005, be amended by deleting the following:

John Street	Both	Broadway and Townline	Any time except that portion of the east side extending from the point intersected by the southerly boundary of Lot 64 according to Registered Plan 195 in a northerly direction from a distance of 25 metres (80 feet) for a longer period of time than 15 minutes.
Laneway north of Armstrong Street east of Mill Street	Both	Mill Street and RBC parking lot	Any time
Lane running north and south	West	First Avenue and Second Street	Any time
Laneway between Broadway and First Avenue	Both	First Street and Second Street	Any time

2. That Schedule "A" (parking restrictions) of By-law 78-2005, be amended by adding the following:

John Street	Both	Broadway and Townline	Any time except that portion of the east side which is marked and begins 13 metres south of Lane 4-E-1 and ends at the southerly boundary of 7 John Street.

Lane 2-E-1	Both	Clara Street and Louisa Street	Any time
Lane 2-E-2	Both	Louisa Street and Faulkner Street	Any time

Lane 2-E-4	Both	Faulkner Street and lane 2-N-2	Any time
