By-law 078-2005

A By-law to Regulate Traffic in the Town of Orangeville

WHEREAS Section 11 of the Municipal Act, 2001, as amended, authorizes municipalities to pass by-laws prohibiting or regulating parking on highways and on properties other than highways;

AND WHEREAS Section 102 of the said Act authorizes municipalities to pass by-laws requiring the owners or operators of parking lots or other parking facilities, to which the public has access, to provide designated parking spaces for the use of vehicles operated by or carrying persons with disabilities;

AND WHEREAS Sections 100 through 101 of the said Act authorizes municipalities to pass by-laws for prohibiting unauthorized parking on municipal or private property;

AND WHEREAS the said Act provides that fines may be charged for breaches of bylaws passed pursuant to the powers set out therein and further provides for the removal, impounding or restraining or immobilizing of any vehicle parked on a highway or on municipal property in contravention of a by-law or of the Highway Traffic Act, as amended;

AND WHEREAS Subsection 175(13) of the Highway Traffic Act, as amended, provides that the Council of a municipality may, in relation to highways under its jurisdiction, by by-law designate school bus loading zones in accordance with the said Act and the regulations made thereunder;

AND WHEREAS the Corporation of The Town of Orangeville is desirous of regulating traffic and restricting parking on highways within its boundaries and on municipal properties;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF ORANGEVILLE ENACTS AS FOLLOWS:

1 DEFINITIONS

In this By-law:

"accessible parking permit" means an accessible parking permit issued under section 26 of the *Highway Traffic Act*, as amended, and Regulation 581 made thereunder, or a currently valid permit, number plate or other marker or device bearing the international symbol of access for the disabled and issued by another jurisdiction.

(Amended by By-Law 77-2011, Sept. 26/11)

"Administrative Penalty By-law" means the Administrative Penalty By-law of the Town being By-law 2025- 049, as amended from time to time, or any successor thereof;

(Amended by By-law 2025-051)

"angle parking" means that, where angle parking is permitted, no person shall park a vehicle except at the angle indicated by authorized markings or signs and so that the front end of the vehicle is nearest to the edge of the roadway.

"authorized emergency vehicle" means a vehicle as defined in subsection 144(1) of the *Highway Traffic Act*, as amended.

"boulevard" means that portion of highway, other than a sidewalk and/or entrance from a road to a private road, driveway, or lane, between the curb lines or the lateral lines of a roadway and the adjacent property line.

"by-law" means a by-law of The Corporation of the Town of Orangeville.

"bicycle lanes" means a lane designated for bicycles only when it is striped, signed and marked with a large white bicycle stencil on the pavement. (Amended by By-Law 77-2011, Sept. 26/11)

"commercial motor vehicle" means a motor vehicle having permanently attached thereto a truck or delivery body and includes ambulances, hearses, fire apparatus, buses and tractors used for hauling purposes on the highways.

"Corporation" means The Corporation of the Town of Orangeville.

"Council" means the Council of the Corporation.

"crosswalk" means that part of a highway at an intersection that is included within the connections of the lateral lines of the sidewalks on opposite sides of the highway measured from the curbs or, in the absence of curbs, from the edges of the traveled portion of a roadway at an intersection or elsewhere distinctly indicated for pedestrian crossing by signs or signals or by lines or other markings on the surface.

"curb" means the edge of a traveled portion of the highway.

"designated" accessible parking space" means a parking space designated under this By-law for the exclusive use of a vehicle displaying an accessible

parking permit in accordance with the requirements of the *Highway Traffic Act*, as amended, the regulations made thereunder and this By-law. (Amended by By-Law 77-2011, Sept. 26/11)

"electric vehicle" means a vehicle that is propelled by one or more electric motors.

(Amended by By-Law 016-2018, April 9/18)

"electric vehicle charging station" means a device that supplies electric current for the purpose of recharging electric vehicles.

(Amended by By-Law 016-2018, April 9/18)

"electric vehicle parking space" means a parking space for the exclusive use of electric vehicles while plugged into an electric vehicle charging station.

(Amended by By-Law 016-2018, April 9/18)

"gross weight" means the combined weight of vehicle and load.

"heavy trucks" means any vehicle in excess of a gross weight of 4.6 metric tonnes.

"highway" means a common and public highway, street, avenue, parkway, driveway, square, place, bridge, viaduct or trestle, designed and intended for, or used by, the general public for the passage of vehicles and includes the area between the lateral property lines thereof.

"holiday" means a holiday as defined in subsection 20(1) of the Interpretation Act, as amended.

"intersection" means the area within the lateral curb lines or, if none, then of the lateral boundary lines of two or more highways (roads) that join one another at an angle, whether or not one highway crosses the other (as is the case with a "T" intersection).

"Law Enforcement Officer" means a municipal by-law enforcement officer, a provincial offences officer, a police officer, or a fire chief or his designate.

"motor vehicle" means an automobile, motorcycle, motor assisted bicycle, and any other vehicle propelled or driven other than by muscular power, but does not include a motor vehicle running upon rails, or a motorized snow vehicle, traction engine, farm tractor, self-propelled implement of husbandry or road building machine within the meaning of the *Highway Traffic Act*.

"municipal or private property" means any open area or portion of a structure, other than a street or highway, intended for the temporary parking of vehicles

and on which there are designated parking spaces, whether their use involves the payment of a fee or otherwise.

"officer" means a police officer, a police cadet, a municipal law enforcement officer, a person authorized to enforce the Highway Traffic Act, or any person appointed by Council to enforce this by-law. (Amended by By-law 2023-081, November 13, 2023)

"one-way highway" means a street upon which vehicular traffic is limited to movement in one direction.

"owner" when used in connection with real property means:

in the case of a property upon which there is a condominium, the corporation incorporated under the *Condominium Act*, as amended, for that condominium; or otherwise

the person shown as the owner of the property on the last revised assessment roll of the Corporation.

"parallel parking" means that, where parallel parking is permitted, no person shall park a vehicle except in parallel to other parked cars. Cars parked in parallel are in one line parallel to the curb, with the front bumper of each car facing the back bumper of an adjacent one and with the right tires next to the curb.

"park or parking" when prohibited means the standing of a vehicle, whether occupied or not, except when standing temporarily for the purpose of and while actually engaged in loading or unloading merchandise or passengers.

"parking space" means a portion of the surface of a highway designated by suitable markings, the use of which for the parking of a vehicle is controlled and regulated.

"parking ticket" means the certificate of parking infraction and parking infraction notice prescribed under section 20 of the *Provincial Offences Act*, as amended.

"pedestrian" includes a person on foot, a person in a wheelchair and children in wheeled carriages.

"person" includes an individual, corporation, firm, or agent thereof.

"person with disabilities" means an individual who is unable to walk unassisted for more than 200 metres without great difficulty or danger to his or her health or safety and who has been certified as such by a person legally

qualified to practice in Canada as a physician, chiropractor, occupational therapist, osteopath or physiotherapist. (Amended by By-Law 77-2011, Sept. 26/11)

"private roadway" means any private road, lane, ramp or other means of vehicular access to or egress from a building or structure, and it may include part of a parking lot.

"public parking facility" means a parking lot or other parking facilities on private property or on property owned or occupied by the Corporation or any local board thereof, to which the public has access, whether on payment of a fee or otherwise.

"residential zone" as defined in the Corporation's Zoning By-law 22-90, as amended, means the ER, R, RM1, RM2, C5 and D Zones.

"roadway" means the part of the highway that is improved, designed, or ordinarily used for vehicular traffic, but does not include the shoulder, and where a highway includes two or more separate roadways the term "roadway" refers to any one roadway separately and not to all of the roadways collectively.

"school bus" means a bus used for the transportation of children to and from school that bears on the rear thereof the words "Do not pass when signals flashing"; is equipped with two (2) red signal lights on the rear thereof and two (2) red signal lights on the front thereof; and is painted chrome yellow with black lettering and trim.

"school bus loading zone" means an area on a highway or on private property as designated by Schedule B of this By-law where signs are on display indicating that parking is prohibited in order to provide school buses with the facility to load or discharge passengers.

"school crossing guard" means a person employed by the Corporation to direct the movement of children crossing a highway.

"sidewalk" means that portion of a highway between the curb lines or the lateral lines of a roadway and the adjacent property lines intended for the use of pedestrians.

"sign" means a properly worded or symbolic sign approved by the Ministry of Transportation of the Province of Ontario or the Corporation.

"signalized intersection" means an intersection that is controlled by traffic control signals.

- **"stand or standing"** when prohibited, means the halting of a vehicle, whether occupied or not, except for the purpose of and while actually engaged in receiving or discharging passengers.
- "stop" when required, means a complete cessation of movement.
- "stop or stopping" when prohibited, means any stopping of a vehicle, even momentarily, whether occupied or not, except when necessary to avoid conflict with other traffic or in compliance with the directions of a constable or other police officer or of a traffic control sign or signal.
- "Town" means the Corporation and its locality, including its geographic area.
- "traffic" includes pedestrians, ridden animals, vehicles, and other conveyances either singly or together while using any highway for the purpose of travel.
- "traffic control device" means any sign, highway, curb or sidewalk marking, or other device erected or placed under the authority of the municipal Council for the purpose of regulating traffic.
- "traffic control signal" means that part of a traffic control signal system that consists of one set of no less than three (3) coloured lenses, red, amber and green, mounted on a frame and commonly referred to as a signal head.
- **"traffic sign"** means any device manually, electrically or mechanically operated for the regulation of traffic.
- **"trailway"** means a recreational trail that is provided by the Corporation for use by pedestrians, cyclists, and other users other than persons on motorized vehicles and horses, and which is located within road allowances, or other lands or easements owned by the Corporation.
- "Treasurer" means the Treasurer of the Corporation.
- **"U-turn"** when prohibited, means that no owner or operator of a vehicle upon a highway shall turn a vehicle continuously so as to proceed in the opposite direction.
- "vehicle" includes a motor vehicle, trailer, traction engine, farm tractor, road building machine and any vehicle drawn, propelled, or driven by any kind of power, including muscular power, but does not include a motorized snow vehicle or a street car

"walkway" means any portion of a highway so designated as a walkway which shall also mean pathway or footpath by this By-law and intended for the use of pedestrians.

"wheelchair" means a chair mounted on wheels driven by muscular or any other kind of power and used for the carriage of a person who has a physical defect or disability.

2 ENFORCEMENT

2.1 **Traffic and Enforcement** – A police officer, police cadet, municipal law enforcement officer or other person authorized to enforce the Highway Traffic Act, as amended, are hereby vested with the authority of administering and enforcing the provisions of this by-law.

2.2 **Parking and Enforcement** - The Law Enforcement Officers of the Corporation shall enforce all parking regulations as outlined in Section 3 and Section 4 of this By-law.

3 PARKING

- 3.1 **Parallel Parking Right Wheels to Curb** No person shall park a vehicle on any highway other than a one-way street unless on the right hand side of the highway, facing in the direction of the traffic using that side of the street, and unless the right front and right rear wheels of the vehicle are parallel and no more than 15 cm from the curb.
- 3.2 **Angle Parking** Where angle parking is permitted, no person shall park a vehicle except:
 - 3.2.1 Within a parking space so that no part of the vehicle encroaches onto an adjacent parking space where the parking spaces are clearly marked.
 - 3.2.2 In all cases so that the right front wheel of the vehicle is no more than 15 cm from the edge of the roadway.
- 3.3 **One-Way Street** Where parking is permitted on a one-way street, a person may park a vehicle facing only in the direction in which traffic is authorized to proceed with the front and rear wheels parallel and not more than 15 cm from the curb.
- 3.4 **Parking Prohibited** No person shall park or stand a vehicle or portion thereof upon any highway or municipally-owned property in any of the following places:
 - 3.4.1 On a sidewalk.

- 3.4.2 On a boulevard, unless an encroachment agreement has been entered into with the Corporation.
- 3.4.3 In front of an entrance on the highway to or from a private road, driveway, or lane.
- 3.4.4 Within an intersection or within 15 metres of an intersection.
- 3.4.5 On a crosswalk or within 9 metres of a crosswalk.
- 3.4.6 Within 9 metres of a stop sign unless otherwise posted.
- 3.4.7 Within 15 metres of any bridge or the nearest rail of a rail crossing.
- 3.4.8 In such a manner as to obstruct traffic or in a position or place that prevents or is likely to prevent the removal of any other vehicle, parked or standing on the highway.
- 3.4.9 In such a manner as to obstruct or prevent the clearing or removal of snow from the highway.
- 3.4.10 Within 1.5 metres of a fire hydrant or in a manner so as to prevent access to a fire hydrant in the case of an emergency.
- 3.4.11 On the inside radius where there is a 90-degree bend in the road, more or less, for a distance of 9 metres in each direction, measured from the point of intersection of the projected curb lines or edge of asphalt and along the curb line or edge of asphalt.
- 3.4.12 In any municipally-owned park or recreation facility parking lot between the hours of 11:30 p.m. and 7:30 a.m.
- 3.4.13 On municipal property except in a designated parking zone.
- 3.4.14 In a municipal parking lot between the hours of 11:30 p.m. and 7:30
- 3.4.15 In any public park, trailway or open space areas that do not have designated parking areas.
- 3.4.16 In a designated accessible parking space. (Amended by By-Law 77-2011, Sept. 26/11)
- 3.5 **Parking Prohibited Where Signs Erected -** When signs are erected and are on display, no person shall park a vehicle upon any highway:
 - 3.5.1 Within 15 metres of the intersection, where there is a traffic control system installed at an intersection on a highway.
 - 3.5.2 On the side of a highway adjacent to any school property between the hours of 8:30 a.m. and 4:30 p.m.
 - 3.5.3 In excess of the posted time limit.

- 3.6 **Parking Restrictions** When signs have been erected and are on display, no person shall park or stop any vehicle upon the highways listed in Column 1 of **Schedule A** to this By-law, on the side of the highway set out in Column 2, between highways or portions of highways listed in Column 3 during the days and times set out in Column 4.
- 3.7 **No Overnight Parking December to March** When signs have been erected and are on display at the entrances to the Town, no person shall park a vehicle upon any highway in the Town or on municipal property and parking lots, between the hours of 2:00 a.m. and 7:00 a.m. from the 1st day of December in each year until the 31st day of March in the following year, unless otherwise posted.

(Amended by By-Law 047-2018, Dec. 10/18)

- 3.8 **Overnight Parking Permitted** The provisions of Section 3.7 shall not apply to authorized emergency vehicles and vehicles registered to the Corporation.
- 3.9 **Parking Vehicles** No person shall park or store a vehicle which is in excess of 7 metres in length or 3.5 metres high on a highway in a residential zone other than a school bus that is permitted to be parked from Monday to Friday between the hours of 9 a.m. and 3:30 p.m. for a maximum of three hours daily within the permitted times.

(Amended by By-Law 18-2009, March 9/09)

3.9.1 The provisions of subsection 3.9 do not apply to prohibit the parking or standing of any such vehicle upon a highway in any residential zone while the operator thereof is actually engaged in the delivery of goods or services to any premises within any such zone, or to prohibit the parking or standing of any bus or school bus upon any highway in any residential zone while the operator thereof is actually engaged in the embarking or disembarking of passengers in any such zone.

3.10 **School Bus Loading Zone**

- 3.10.1 When signs are on display, the locations listed in Column 1 of Schedule B of this By-law are hereby designated as school bus loading zones on the portions of the roadways set out in Column 2 of the said Schedule B.
- 3.10.2 No Person shall park, stop or stand a vehicle, except a school bus, in a school bus loading zone between the hours of 8:00 a.m. to 4:00 p.m., Monday to Friday, except for designated holidays.
 (Amended by By-Law 16-2008, February 11/08)

- 3.10.3 For the purposes of this by-law a designated holiday is a day when the school is closed by the appropriate school board.

(Amended by By-Law 104-2009, September 28/09)

3.11 Bicycle Lanes

- 3.11.1 When signs are on display, the highways listed in Column 1 of Schedule O of this By-law in the direction set out in Column 2 between the locations set out in Column 3 are lanes designated for bicycles only, unless:
- 3.11.1.1 Ingress to or egress from a private lane or driveway adjacent to the bicycle lane.
- 3.11.1.2 Making a turn at a highway intersecting the bicycle lane.
- 3.11.1.3 Entering or exiting a curb lane used for parking.
- 3.11.1.4 Loading or unloading of a person with a disability, while actively engaged in doing so.
- 3.11.1.5 Operating a school bus while actively engaged in picking up or dropping off school children.
- 3.11.1.6 Operating a taxicab while actively engaged in loading or unloading of passengers.
- 3.11.1.7 Operating a transit bus while actively engaged in picking up or dropping off passengers.
- 3.11.1.8 Use by ambulances, police or fire service vehicles or any other vehicle actively engaged in responding to an emergency.
- 3.11.1.9 Use by vehicles operated by a public utility, including utilities providing telecommunications, energy, water supply, wastewater and public works related services.
 (Amended by By-Law 77-2011, Sept. 26/11)

4 PARKING REGULATIONS/RESTRICTIONS

- 4.1 **Parking at Regulated Spaces** Where parking is regulated the following additional regulation shall apply:
 - 4.1.1 **Parallel Parking** Where a parking space has been designated by lines painted on the highway or in a parking lot, no person shall park any vehicle in such a manner that it is not wholly within the area designated as a parking space.

4.2 Restricted Parking

- 4.2.1 Where official signs in accordance with the regulations made under the Highway Traffic Act, as amended, have been erected and are on display, no person shall park any vehicle on a portion of the highway or municipal parking lots as set out in **Schedule C** of this By-law, for a period longer than two (2) hours.

- 4.2.2 Where a parked vehicle has properly displayed a valid accessible parking permit, the owner and driver of the parked vehicle are exempt from the provisions of Section 4.2.1.

 (Amended by By-Law 081-2017, September 11, 2017)
- 4.3 Parking at Municipally-Owned or Controlled Facilities/Property
 - 4.3.1 (Section deleted By-Law 11-2007, February 5/07)
 - 4.3.2 Where signs are erected and on display, no person shall park or leave any motor vehicle on municipally-owned or controlled property for a period in excess of twenty-four (24) hours.
 - 4.3.3 Notwithstanding Section 4.3.2 of this By-law, to the extent that an individual attending a social event at which alcohol is served in a municipal recreation centre believes that he or she may have consumed too much alcohol to drive safely, he or she may leave their vehicle overnight and without penalty at the recreation centre, providing that staff of the Corporation have been notified and have issued a permit to the individual, which permit shall be displayed in a conspicuous area of the said vehicle.
 - 4.3.4 Wrecked, dismantled, discarded, inoperative, abandoned or unplated vehicles are not permitted on municipally-owned or controlled property, and will be subject to the enforcement clauses as identified in Section 11 of this By-law.
 - 4.3.5 Unlicensed machinery or objects or parts are not permitted on municipal owned property and will be subject to the enforcement clauses as identified in Section 11 of this By-law.
 - 4.3.6 Notwithstanding Section 4.3.2 of this By-law, overnight parking in the municipal parking lots at the rear of 168–178 Broadway, 82–90 Broadway, Rotary Park and Fendley Park is permitted in the rows designated by signage.

- 4.3.7 Notwithstanding Section 4.3.2 of this By-law, no person shall park a nonelectric vehicle within a designated electric vehicle parking space. (Amended by By-Law 016-2018, April 9/18)
- 4.3.8 Notwithstanding Section 4.3.2 of this By-law, no person shall park a vehicle or electric vehicle not being actively connected to an electric vehicle charging station.

 (Amended by By-Law 016-2018, April 9/18)

5 DESIGNATED ACCESSIBLE PARKING

- 5.1 No person shall park or leave any motor vehicle in a designated accessible parking space provided by the owners of a privately-owned parking area without the authority of the owner or occupant of such property or on property owned or controlled by the Corporation or any local board thereof.

 (Amended by By-Law 77-2011, Sept. 26/11)
- 5.2 Designated accessible parking spaces shall be distinctly signed in accordance with Regulation 581 made under the Highway Traffic Act, as amended. (Amended by By-Law 77-2011, Sept. 26/11)
- 5.3 A sign marking a designated accessible parking space shall be mounted on a permanent post or other vertical surface one (1) metre in height to the bottom, which post is to be located at the end of the designated accessible parking space at the point marking the midpoint in width of the parking space, and shall not be located so as to block vehicular access to the designated accessible parking space.

(Amended by By-Law 77-2011, Sept. 26/11)

- 5.4 The erection and maintenance of signs indicating designated accessible parking spaces shall be the responsibility of the owner of the property. All such signs shall be the recognized official signage for spaces to be used exclusively by permit holders. The signs shall be placed upright on a post, or, if necessary, fixed to a wall so as to be clearly visible to the motoring public.

- 5.5 No person who is not a person with disabilities shall display an accessible parking permit or use a designated accessible parking space when not transporting a person with disabilities in the vehicle.

- 5.6 All accessible parking permits shall be displayed on the sun visor or on the dashboard of a vehicle so that the international symbol of access for the disabled, the permit number and the expiry date of the permit, are clearly visible from the outside of the vehicle.

6 ONE-WAY HIGHWAYS

6.1 **One-Way Highways** - When signs have been erected and are on display, the highways set out in Column 1 of **Schedule D** of this By-law are designated for one-way traffic only between the limits set out in Column 2 and in the direction as set out in Column 3 of the said **Schedule D**.

7 STOP SIGNS, YIELD RIGHT-OF-WAY SIGNS AND SIGNALIZED INTERSECTIONS

- 7.1 **Stop Signs** The intersections on highways set out in **Schedule E** of this By-law are hereby designated as intersections where stop signs shall be erected, and signs shall be erected in the locations listed in the said **Schedule E**.
- 7.2 **Erection of Stop Signs** Every sign erected pursuant to Section 7.1 of this Bylaw shall comply with the regulations of the Ministry of Transportation.
- 7.3 **Yield Signs** The intersections on highways set out in Column 1 of Schedule F of this By-law are hereby designated as intersections where yield right-of-way signs shall be erected at the locations indicated in Column 2 of the said **Schedule F**.
- 7.4 **Erection of Yield Signs** Every sign erected pursuant to Section 7.3 shall comply with the regulations of the Ministry of Transportation.
- 7.5 **Signalized Intersections** The intersections on the highways set out in **Schedule G** of this By-law are hereby designated as signalized intersections. (Amended by By-Law 28-2011, April 4/11)

8 SPEED LIMITS

- 8.1 **Speed Limits** No person shall drive a motor vehicle at a rate of speed greater than 50 kilometres per hour on any highway within the Town save and except those highways or portions of highways set out in Column 1 of **Schedule H** of this By-law, from the limit set out in Column 2 to the limit set out in Column 3 and at the rate of speed set out in Column 4 of the said **Schedule H**.
- 8.2 **Designated 40 km/h Areas** Notwithstanding Section 8.1 no person shall drive a motor vehicle at a rate of speed greater than 40 kilometres per hour on any highway in the designated areas within the Town bounded by the limits set out in Column 2 and Column 3 of **Schedule P** (Designated 40 km/h Areas) of this Bylaw, and at a rate of speed set out in Column 5 of **Schedule P**, with the

exception of the highways set out in Column 4 of **Schedule P**. (Amended by By-law 2021-012, February 2021)

9 OPERATION OF VEHICLES

- 9.1 **U-Turns** No driver or operator of a vehicle shall make a U-turn on any highway unless it can be made in safety without interfering with other traffic.
- 9.2 **No Left Turn** When signs have been erected and are on display, no driver or operator of a vehicle shall turn a vehicle to the left at the intersection named in Column 1 of **Schedule I** of this By-law in the direction set out in Column 2 during the days and times set out in Column 3 of the said **Schedule I**.
- 9.3 **Funerals** No person shall drive or operate a vehicle so as to intersect a funeral or any other properly authorized procession such, as a parade, while it is in motion on a highway except under the direction of a police officer.
- 9.4 **Stopping in an Intersection -** No person shall stop a vehicle in an intersection.
- 9.5 **Heavy Trucks** When signs are displayed, no person shall operate a vehicle having a gross weight in excess of 4.6 metric tonnes on the highways or parts of highways set out in Column 1 of **Schedule J** of this By-law.
- 9.6 **Exceptions** Section 9.5 of this By-law shall not apply to vehicles making deliveries to, or removals from, any premises abutting the highways or parts thereof referenced in Section 9.5 of this By-law, and privately owned vehicles driven to or from the owner's residence abutting the said highways or parts thereof.
- 9.7 The driver of a vehicle emerging onto a roadway over a sidewalk or footpath shall bring the vehicle to a full stop immediately before driving onto a sidewalk or footpath and upon proceeding shall yield the right-of-way to pedestrians upon the sidewalk or footpath.
- 9.8 **Lane Designations** When signs have been erected and are on display, a driver or operator of a vehicle shall follow the direction indicated on the sign and as set out in **Schedule K** of this By-law.
- 9.9 **Right Turn Only** When signs have been erected and are on display, a driver or operator of a vehicle shall, when travelling southbound on Second Street approaching the Fifth Avenue intersection, turn right only onto Fifth Avenue and proceed in a westerly direction only.

9.10 **Public Parks/Open Spaces** - Motorized vehicles are prohibited from operating in all public parks and opens spaces with the exception of Town maintenance vehicles and authorized emergency vehicles.

10 SCHOOL CROSSING GUARDS

10.1 The intersections on highways set out in **Schedule L** of this By-law are designated as intersections where school crossing guards will be placed for the safety of children crossing the road while traveling to and from school.

10A COMMUNITY SAFETY ZONES

10A.1 When signs are on display, the highways set out in **Schedule N** shall be designated as Community Safety Zones.

(Amended by By-Law 63-2006, June 5/06)

11 ENFORCEMENT AND PENALTIES

- 11.1 **Acts to Govern** The provisions of this By-law shall be subject to the provisions of the *Highway Traffic Act* and the Provincial Offences Act, as applicable, the regulations made thereunder and amendments thereto.
- 11.2 Penalty Any person who contravenes any provision of this By-law shall be guilty of an offence and, upon conviction, is liable to a set fine as set out in Schedule M of this By-law, and every such fine shall be recoverable under the provisions of the Provincial Offences Act, as amended.
- 11.3 **Set Fines and Short Form Wordings** The set fines and short form wordings shall be as set out in Schedule M of this By-law. The owner of a vehicle involved in the contravention of this By-law, notwithstanding that he or she was not the driver of the vehicle at the time of the contravention, is guilty of an offence and is liable to the fine prescribed pursuant to this By-law unless, at the time of the offence, the said vehicle was in the possession of some person other than the owner without the owner's consent.
- 11.4 The owner of a vehicle involved in the contravention of this By-law, notwithstanding that he or she was not the driver of the vehicle at the time of the contravention, is guilty of an offence and is liable to the fine prescribed pursuant to this By-law unless, at the time of the offence, the said vehicle was in the possession of some person other than the owner without the owner's consent.
- 11.5 Any person who contravenes Section 5 of this By-law shall be guilty of an offence and shall be liable, upon conviction therefor, to the penalties as prescribed under the *Highway Traffic Act*, as amended, which penalties shall be recoverable under the *Provincial Offences Act*, as amended.

- 11.6 Where a vehicle is found to be parked in contravention of any provision of this By-law, the Law Enforcement Officer so finding the vehicle shall attach to it a parking ticket in the form of a serially numbered notice stating the following:
 - (a) The licence plate number and a concise description of the vehicle.
 - (b) That the vehicle is unlawfully parked.
 - (c) The date, time and place of the alleged offence.
- 11.7 Parking tickets issued pursuant to this By-law shall be prepared in triplicate and the Law Enforcement Officer issuing a parking ticket shall attach one (1) copy to the vehicle and deliver the other copies to the office of the Treasurer.
- 11.8 **Payment Out of Court** Notwithstanding all other provisions of this By-law with respect to penalties, the driver, operator or owner of the vehicle in respect of which a parking ticket has been issued may report to the office of the Treasurer within fifteen (15) days of the issuance of the parking ticket to make payment out of court of the specific penalty provided for such offence by this By-law, and, upon such payment, a receipt shall be given to the person making the payment and no further proceedings shall be taken under this By-law with respect to the said offence alleged in the parking ticket. (Amended by By-Law 77-2011, Sept. 26/11)
- 11.9 If payment is not voluntarily made in accordance with the procedure provided in this Section 11, the procedure as set out in Part II of the Provincial Offences Act, as amended, and the penalties provided in this By-law shall apply.
- 11.10 A Law Enforcement Officer upon discovery of any vehicle parked or standing in contravention of this By-law may cause it to be moved or taken to and placed or stored in a suitable place, at the owner's expense, and all costs and charges for removing, care and storage thereof, if any, are a lien upon the vehicle, which may be enforced in the manner provided by the *Repair and Storage Liens Act*, as amended.
- 11.11 **Contravention of By-law** Every person who contravenes any provision of this By-law is guilty of an offence and is liable upon conviction to a fine of not more than \$2,000.00 exclusive of costs.
- 11.12 **Other Penalties** Every person who contravenes any provision of this By-law is guilty of an offence and, where a penalty for the contravention thereof has not otherwise been provided for, is liable, upon conviction therefore, to a fine of not less than \$50.00 and not more than \$2,000.00, exclusive of costs
- 11.12.1 Section 11.9 and 11.11 shall be enforced pursuant to and in accordance with the provisions of the Provincial Offences Act, as amended.

- 11.13 Sections 3, 4, 5.1, and 9.4 are hereby designated as parts of this By-law to which the Administrative Penalty By-law applies.

- 11.14 Any person who contravenes any Designated Provision shall, upon issuance of a penalty notice in accordance with the Administrative Penalty By-law, be liable to pay an administrative penalty and any applicable administrative fees.

12 GENERAL

- 12.1 **Times** The times mentioned in this By-law shall be those commonly observed including standard time and daylight saving time.
- 12.2 **Highway Traffic Act** Any provision of this By-law which is inconsistent with the *Highway Traffic Act*, as amended, is deemed to be repealed.
- 12.3 **Unassumed Roads** The provisions of this By-law apply to all of the roads in the town, including streets and roads in unassumed subdivisions which have been dedicated to the Town as public highways.
- 12.4 **Exemptions** The provisions of this By-law shall not apply if compliance therewith would be impracticable with respect to the following types of vehicles:
 - 12.4.1 Authorized emergency vehicles.
 - 12.4.2 Vehicles engaged in works for or on behalf of the Corporation,Orangeville Hydro Limited, the County of Dufferin and the Ministry of Transportation.
- 12.5 **Severability** If any section, clause, or provision of this By-law is for any reason declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the By-law as a whole or any part thereof other than the section, clause or provision so declared to be invalid, and it is hereby declared to be the intention of Council that all remaining sections, clauses or provisions of this By-law shall remain in full force and effect until repealed, notwithstanding that one or more sections, clauses or provisions thereof have been declared to be invalid.
- 12.6 **Schedules** The schedules referred to in this By-law shall form part of this By-law. Each entry in a column of a schedule shall be read in conjunction with the entry and not otherwise.


