BY-LAW NUMBER 80-91

BEING A BY-LAW TO AMEND ZONING BY-LAW NUMBER 22-90 TO REZONE PROPERTIES ON THE CORNER OF TOWNLINE & GREEN STREET TO CONVENIENCE COMMERCIAL AND INDUSTRIAL

WHEREAS THE CORPORATION OF THE TOWN OF ORANGEVILLE DEEMS IT APPROPRIATE TO ENACT THIS BY-LAW.

NOW THEREFORE THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

- 1. Zoning Map D7 to By-law No. 22-90 as amended, is further amended by rezoning certain lands from the Industrial (M1) zone to Convenience Commercial Holding "C4(H)" site specific zone and Industrial (M1) site specific zone, as shown on Schedule "A" and Schedule "B" attached.
- 2. Zoning Map D7 to By-law No. 22-90 is further amended by adding the words "Special Provision 24.66" and "Special Provision 24.67", as shown on Schedule "A" attached.
- 3. Section 24, Special Provisions, of By-law 22-90, is hereby amended by adding the following Special Provisions:
 - "24.66

Notwithstanding the provisions of the Convenience Commercial holding "C4(H) zone, on lands described as Lot 29 and Part of Lot 30, Plan 219, Town of Orangeville, County of Dufferin, the following provisions shall apply;


- a) A Minimum Front Yard of 0 metres shall be required
- b) A Minimum Interior Side Yard of 0 metres shall be required
- c) A Minimum Rear Yard of 0 metres shall be required
- d) All other applicable regulations of By-law 22-90 shall apply."

"24.67

Notwithstanding the provisions of the Industrial (M1) zone, on lands described as Part of Lot 30, Plan 219, Town of Orangeville, County of Dufferin, the following provisions shall apply;

- a) A Minimum Lot Area of 905 square metres shall be required
- b) A Minimum Front Yard of 6.5 metres shall be required
- c) A Minimum Interior Side Yard of 0 metres shall be required
- d) A Minimum Rear Yard of 0 metres shall be required
- e) All other applicable regulations of By-law 22-90 shall apply."
- 4. This By-law shall take effect from the date of its passage by Council and shall come into force either upon approval by the Ontario Municipal Board or upon compliance with Subsection 34 (19) of the Planning Act, S.O., 1983.
