## THE CORPORATION OF THE TOWN OF ORANGEVILLE

## BY-LAW NUMBER 52-97

A by-law to amend By-law 22-90, as amended (East side of B Line, south side of Highway 9, Tribunal Developments Inc., Montgomery Village II),

WHEREAS THE CORPORATION OF THE TOWN OF ORANGEVILLE DEEMS IT APPROPRIATE TO ENACT THIS BY-LAW.

NOW THEREFORE THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

1. THAT Map C1 of Schedule "A" to By-law 22-90, as amended, is hereby further amended by changing the zone category within the area of the subject property, all as shown on Schedüle "A" attached to this by-law, from "Development (D) Zone" to "Residential First Density (R1) (H) S.P. 24.102 Zone", Residential Second Density (R2) (H) S.P. 24.103 Zone, Residential Sixth Density (R6) (H) S.P. 24.104 Zone, Residential Sixth Density (R6) (H) S.P. 24.105 Zone, Multiple Residential Medium Density (RM1) (H) S.P. 24.106 Zone, Institutional (INST) (H) Zone, Open Space Recreation (OS1) Zone and Open Space Conservation (OS2) Zone.
2. That Section 24 as amended, is hereby further amended by adding the following new subsections:



Permitted Encroachment for Stairs and Porches (maximum)

$24.106 \quad$ Notwithstanding the provisions of Section 12.2 (Regulations in the Multiple Residential Medium Density (RM1) Zone), the provisions of Section 5.2 (Accessory Buildings and Structures) and the provisions Section 5.22 (Yard Encroachments) the following regulations shall apply to the lands zoned RM1 S.P. 24.106:

Front Yard (minimum) $\quad 4.5$ metres to house, 6.0 metres to vehicle entry to garage.
