

The Corporation of the Town of Orangeville

By-law Number 047 - 2018

A by-law to amend Traffic By-law 78-2005 with respect to various housekeeping matters.

Whereas the Municipal Act, S.O. 2001, c.25, S.11, authorizes a municipality to pass by-laws respecting matters within the jurisdiction of highways including traffic and parking on highways;

And whereas the Council of the Corporation of the Town of Orangeville deems it expedient to amend By-law No. 78-2005, as amended;

Be it therefore enacted by the municipal Council of The Corporation of the Town of Orangeville as follows:

- That Section 4.3.6 (Parking at Municipally-Owned or Controlled Facilities/Property) of By-law 78-2005 be deleted and replaced by the following:
 Notwithstanding Section 4.3.2 of this By-law, overnight parking in the municipal parking lots at the rear of 168 178 Broadway, 82 90 Broadway, Rotary Park and Fendley Park is permitted in the rows designated by signage.
- 2. That Section 3.7 (No Overnight Parking December to March) of By-law 78-2005 be deleted and replaced by the following:
 When signs have been erected and are on display at the entrances to the Town, no person shall park a vehicle upon any highway in the Town or on municipal property and parking lots, between the hours of 2:00 a.m. and 7:00 a.m. from the 1st day of December in each year until the 31st day of March in the following year, unless otherwise posted.
