

#### THE CORPORATION OF THE TOWN OF ORANGEVILLE

#### **BY-LAW NUMBER 48 - 2003**

### A BY-LAW TO AMEND ANIMAL CONTROL BY-LAW 68-2000

WHEREAS the Municipal Act, S.O. 2001, c.25, S.11, authorizes a municipality to pass by-laws respecting matters within the jurisdiction of animals;

AND WHEREAS Council deems it expedient to amend Animal Control By-law 68-2000;

BE IT THEREFORE ENACTED by the Municipal Council of the Corporation of the Town of Orangeville that Animal Control By-law 68-2000 be amended as follows:

- THAT Section 4, sub-section 4.1.4 (a) and (b) be deleted and replaced with the following:
  - 4.1.4 (a) Every person applying for a licence as required by this by-law shall file a complete application form with the Town, or its agent and shall pay the required fee as set out in Schedule "D" of this by-law.
    - (b) Where an owner does not comply with the provisions of sub-section 4.1.1, then in addition to the licence fee established under sub-section 4.1.4 (a), the owner shall be required to pay a processing fee as set out in Schedule "D" of this by-law.
- 2 THAT Schedule "A" Prohibited Animals, be deleted and replaced with Schedule "A" attached.

This amendment has the effect of adding the following to the list of prohibited animals:

- Artiodactyla (such as cattle, goats, sheep, pigs) in the class mammalia
- Anseriformes (such as ducks, geese, swans, screamers);
  Galliformes (such as pheasants, grouse, guineafowls, turkeys); and
  Struthioniformes (such as ostriches, rheas, cassowaries, emus, kiwis) in the class of aves
- 3 THAT Schedule "D" Licensing Fees as attached be added to the by-law.

License Purchased/ Renewed after April 1 <sup>st</sup> in any year	Penalty fee in addition to above fees \$5.00/each	Penalty fee in addition to above fees \$5.00	December 31	-Licenses purchased / renewed after April 1 <sup>st</sup> in any year are subject to a \$5.00 penalty fee, except where the dog is purchased by the owner after April 1 <sup>st</sup> in that year
