A by-law to amend Zoning By-law 22-90 to remove the Holding symbol (H₁) from a portion of the lands described as Part of Lot 2, Concession 1, W.H.S. (Fairgrounds Shopping Centre Limited, 95 First Street, H4/97)


WHEREAS THE CORPORATION OF THE TOWN OF ORANGEVILLE DEEMS IT APPROPRIATE TO ENACT THIS BY-LAW.

NOW THEREFORE THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

1. That Zoning Maps A4 and B4 of Schedule "A" to Zoning By-law 22-90 are hereby amended by removing the holding symbol (H₁) from the lands described in Schedule "B" to this By-law as shown on Schedule "A" to this By-law.

SCHEDULE "B"

Part Lots 1 to 6, Block 20 and part Lots 10 to 15, Block 16, Plan 222, Part of Fifth Avenue, Plan 222, as closed by Instrument No. OR8809, designated as Part 1 on Reference Plan 7R-1502, Town of Orangeville, County of Dufferin.

Fifthly:

Lot 39 and Part Lots 35-38 inclusive, Lots 40 and 41, Plan 275M and Part Lot 2, Concession 1 West of Hurontario Street, designated as Part 1 on Reference Plan 7R-2832, Part 1 on Reference Plan 7R-2521 and Part 1 on Reference Plan 7R-2045, Town of Orangeville, County of Dufferin.

Sixthly:

Part Lot 2, Concession 1 West of Hurontario Street and Lots 7 to 9 Block 20, Lots 1 and 2, Block 21, Plan 222 and Part Lots 1 to 6, Block 20, Part Lots 3 to 5, Block 21, Part Lots 15 to 18, Block 16, Part Lots 10 to 14, Block 17, Plan 222 and Part of Fifth Avenue and Part East Fourth Street, Plan 222 as closed by Instrument No. OR-8809, designated as Part 1 on Reference Plan 7R-4012, Town of Orangeville, County of Dufferin; SAVE AND EXCEPT for Part Lot 1, Block 20, Plan 222, designated as Part 7 on Reference Plan 7R-4410.

B. Part of Pin No. 34022-0024 (LT)

Part of Third Street on Registered Plan 275, designated as Part 1 on Plan 7R-4410, Town of Orangeville, County of Dufferin.

C. Part of Pin No. 34022-0023 (LT)

Part of Third Street (also called the Forced Road through Lot 2, Concession 1 WHS) designated as Part 2 on Reference Plan 7R-4410, Town of Orangeville, County of Dufferin.

D. Part of Pin No. 34022-0008 (LT)

Part of Third Street (also called the Given Road and called the Forced Road through Lot 2, Concession 1 WHS) designated as Part 3 on Reference Plan 7R-4410, Town of Orangeville, County of Dufferin.

E. Part of Pin No. 34022-0008 (LT)

Part of Third Street (also called East Third Street) Registered Plan 222, designated as Part 4 on Reference Plan 7R-4410, Town of Orangeville, County of Dufferin.
