BEING A BY-LAW TO AMEND BY-LAW NUMBER 22-90

WHEREAS THE CORPORATION OF THE TOWN OF ORANGEVILLE DEEMS IT APPROPRIATE TO ENACT THIS BY-LAW.

NOW THEREFORE THE CORPORATION OF THE TOWN OF ORANGEVILLE BY THE MUNICIPAL COUNCIL THEREOF ENACTS AS FOLLOWS:

- By-law 124-88 adopted by the Town of Orangeville on December 12, 1988 is hereby repealed.
- Zoning Maps C2, C3, C4, D2, D3, and D4 of Schedule "A" of By-law 22-90 are amended by deleting the reference to By-law 124/88.
- Zoning Map C2 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone as shown on Schedule "A" to this Bylaw.
- Zoning Map C3 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone, Residential Third Density (R3) Zone, Residential Fourth Density (R4) Zone, Residential Fifth Density (R5) Zone, Multiple Residential Medium Density (RM1) Zone, and Convenience Commercial (C4) Zone as shown on Schedule "B" to this By-law.
- 5. Zoning Map C4 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone and Convenience Commercial (C4)

 Zone as shown on Schedule "C" to this By-law.
- Zoning Map D2 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone as shown on Schedule "D" to this Bylaw.

- 7. Zoning Map D3 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone, Residential Third Density (R3) Zone, Residential Fourth Density (R4) Zone, Residential Fifth Density (R5) Zone, Multiple Residential Medium Density (RM1) Zone and Convenience Commercial (C4) Zone, General Industrial (M1) Zone and Open Space Conservation (OS2) Zone as shown on Schedule "E" to this By-law.
- 8. Zoning Map D4 of Schedule "A" of By-law 22-90 is amended by zoning certain lands Development "D" Zone, Convenience Commercial (C4) Zone, and Open Space Conservation (OS2) Zone as shown on Schedule "F" to this By-law.
- This By-law shall take effect from the date of passage by Council and shall come into force either on approval by the Ontario Municipal Board or upon compliance with Subsection 34(19) of the Planning Act, 1983 as amended.









ZONING MAP NO. TO BY-LAW NO. 22-90 C4




ZONING MAP NO. TO BY-LAW NO. 22-90 D2
