- Fire and explosion safeguards to be undertaken (Section 4.2.2)
- Letter from manufacturer of fireworks stating child labour was not used in the assembly of fireworks (Section 3.5)
- Written permission with respect to the proposed use from registered owner of property/authorized agent (Section 4.2.3)
