Residential Property Demolition Permit Application form

NOTE: This application form is intended for those persons who propose to demolish a residential building within the Town of Orangeville and who require a permit for this work pursuant to By-law 126-2003.

Applications to demolish a residential property are considered by Council following the preparation of a staff report containing comments from the Planning Department, Heritage Orangeville and the Building Department.

You are requested to discuss your demolition plans with the Planning Department and the Building Department prior to submitting the application. If the application for a residential property demolition permit is approved by Council, the demolition permit will be issued by the Chief Building Official. A separate permit will also be required pursuant to the Ontario Building Code Act.

The application fee for a Residential Property Demolition Permit is \$500.00
