



If you are planning to develop or build in the Town of Orangeville, you may be subject to policies that aim to protect the Town's drinking water sources.



Developing and Building Around Municipal Water Supplies

The aim of the Source Water Protection Program is to mitigate potential threats to our municipal drinking water sources by implementing the Clean Water Act, 2006 and policies in the Source Protection Plan.

If you are planning to build or develop in Orangeville, you may be subject to source protection policies contained in the Credit Valley-Toronto and Region-Central Lake Ontario (CTC) Source Protection Plan.

Where Does the Source Water Protection Program Apply?

Policies in the Source Protection Plan protect our sources of drinking water by putting restrictions on threat activities that may adversely impact the quality and quantity of our municipal water supplies.

There are **21 drinking water threat activities** addressed by the source protection policies.

What are some examples of threats to drinking water?



Road Salt & Snow Storage



Dense Non-Aqueous Phase Liquids & Organic Solvents



Fuel Storage
(liquid fuel & heating fuel)



Reducing Recharge
(e.g. paving over a grassed area)

Policies only apply to proponents undertaking or planning to undertake significant drinking water threat activities in a **source protection vulnerable area**.

Source protection vulnerable areas are places on the landscape where our sources of drinking water are most sensitive to contamination or depletion.

To find out if your future development or building site is in a vulnerable area, consult the Town's vulnerable area mapping, available at the Town Hall 2nd floor counter or online at www.ctcswp.ca/are-you-affected.

How Does This Affect Me?

If your proposed building or development property is located within a source protection vulnerable area, you will be required to provide information about the types of activities you intend to undertake on site. The Town's Risk Management Official (RMO) will review this information and issue a Notice to Proceed if the proposed work meets the requirements of the source protection policies.

A Notice to Proceed must be obtained before a planning or building application can advance through the approvals process.

If source protection policies apply to your building or development plans, you may be required to develop a Risk Management Plan (RMP) before a Notice to Proceed can be issued.

RMPs are site specific documents negotiated between the RMO and proponent; they outline the management measures that need to be undertaken in order to ensure the activities occurring on site do not become significant threats to drinking water.

In rare circumstances, an activity may be prohibited by source protection policies. When an activity is prohibited, the application is stopped. In most cases, the proponent will be able to make some adjustments to their plans to ensure their proposal is not prohibited. The RMO is available to review your proposed plans and advise you on your options.
