Mary Lou Archer, Town of Orangeville provided an overview of the grant and advised that the full amount of the grant (\$45,387) was awarded. She noted that local service providers have been met with in order to triage for services. New technology has been purchased and officers have been trained.

Chair Taylor requested clarification for what is included in the mobile technology unit. Mary Lou advised that it includes a laptop with a camera in order to conduct interviews in a comfortable setting for victims.

8. Orangeville 3rd Quarter Report (Inspector Terry Ward to present) (see 3rd Quarter report)

OPP Inspector Ward reviewed the third quarter report from July – September 2021. The calls for service billing summary report does not currently apply as part of the transitional agreement. The OPP is currently building the three year comparison base.

Inspector Ward advised of each segment of crime related to the time standard and weighted hours from the beginning to the end of an investigation.

A noisy vehicles investigation was conducted on Zina Street, with several charges resulting. The enforcement resulted in over a dozen fail to stop at the stop signs with over 17 hours of enforcement.

Inspector Ward advised that the two “black cat” traffic devices have arrived.

It was noted that 90 criminal record checks were completed for participants in local sports in a one-day period. Media blitzes have been popular throughout the Town.


