Highlights (see report for detailed results)

- There have been no public complaints or matters in relation to secondary employment
- In relation to violent crime there has been an increase in assaults compared to the same period last year (21 last year and 26 this year) although this can be attributed to things opening up compared to restrictions in the same period last year due to the pandemic.
- Property crime is down in comparison to last year.
- There is an increase in frauds, particularly both online and telephone frauds. Frauds where a person represents themselves as a family member and requests money is prevalent. They have sent out press releases to alert the public.
- There has been an increase in drug trafficking charges laid as result of good work that is being done by the Street Crimes Unit.
- o In the last period almost 3,485 provincial offences charges have been laid.
- Officers are working hard on enforcement. It continues to be frustrating the number of charges that are stayed or acquitted as result of a charter infringement of a person's right to a timely trial.
- Motor vehicle collisions are up, and the majority of collisions are due to driver inattentiveness.
- Part 1 and Part 3 charges are up from last year. There is a big increase in Part 3 charges in September. (Part 3 is a fine over \$500 and court attendance is required)
- There were 71 false alarms in the 3rd quarter.
- There have been 262 Mental Health Occurrences YTD. The Mobile Crisis Response Team is assisting with Mental Health occurrences, and this is working very well in supporting persons in crisis and diverting them from the Headwaters Hospital ER Dept.
- The Auxiliary Officer Unit has logged in 482.5 hrs. in the past period. This is a very dedicated team doing a lot of great work in the community
- Recent Media Releases: Grandparent Scams, Labour Day Long Weekend Campaign and Commercial Motor Vehicle Blitz
- Black Cat Data was reviewed. There were no huge concerns with the resulting data. The OPP will continue to assess area needs based on volume of traffic, traffic complaints and collisions and place the Black Cat resource accordingly. If a member of the public has a traffic concern, they should communicate this to the OPP by calling the non-emergent number (1 888 310-1122) and report their concern.
