Are you thinking of running for office in the next municipal election?

Candidates

The nomination period for candidates begins on May 2, 2022 and ends on Nomination Day, August 19, 2022. Nomination forms may be filed in person by the candidate or by their agent during normal office hours. On Nomination Day, nominations forms may only be filed between 9:00 a.m. and 2:00 p.m.

The 2022 Municipal and School Board Election will take place on October 24, 2022. The deadline to file the required Nomination Forms for the offices of Mayor, Deputy Mayor, Councillor and School Board Member is Nomination Day, August 19, 2022.





General Manager, Infrastructure Services (Full-time position, 35 hours per week) A member of the Corporate Leadership Team, the General

Manager, Infrastructure Services is accountable for the leadership and administration of all divisions within the Infrastructure Services Department, which includes the Transportation and Development, Capital Works, Public Works, Planning and Building. The successful candidate will provide advice, prepare reports and recommendations to the CAO and elected officials with respect to matters within infrastructure services.

Partial Requirements:

- University degree in Engineering or related field.
- At least 1 (one) of the following: Professional Engineer's (P. Eng) designation from Professional Engineers Ontario (PEO), Member of the Canadian Institute of Planners and a Registered Professional Planner (MCIP RPP), The Certified Building Code Official Designation (CBCO), Masters Level Degree in Public Administration (MPA), or Business Administration (MBA) or related field.
- A minimum of ten (10) years of senior leadership experience involved with overseeing the administration of the infrastructure services functions including transportation, operations, water supply and distribution, sanitary sewage collection and treatment, storm water management, land development, planning and/or building services

Salary Range: \$154,645.40 to \$180,908.00, Band 16 (Salary Market Review rates effective April 1, 2022), on the Town's 2022 Pay Grid, plus a comprehensive benefits

Project Manager, Infrastructure Services (2-year contract, 35 hours per week)

The Project Manager, Capital Works will lead the delivery of complex capital projects, including the delivery of infrastructure in the areas of Water supply, treatment, distribution and metering, Sanitary Sewer collection and treatment, and Storm water management. This position will also lead the delivery of servicing studies to identify long term infrastructure needs, and to evaluate the condition of current infrastructure. This is a two (2) year contract opportunity.

Partial Qualifications:

- A Bachelor's Degree in Engineering, designated as a Professional Engineer (P. Eng.).
- Registered with the Professional Engineers of Ontario.
- Minimum of four (4) to five (5) years of experience leading and delivering large complex infrastructure projects.

Salary Range: \$97,188.00 to \$113,695.40 Band 12 (Salary Market Review rates effective April 1, 2022), on the Town's 2022 Pay Grid, plus a contract benefits package.

Water Works Operators (Two opportunities: One permanent full-time position, one 12-month contract; both 40 hours per week)

Reporting to the Supervisor, Water Works, the Water Works Operators will operate and maintain the Town's Water Supply and Distribution Systems. One position is on a permanent full-time basis, and the other position shall be a twelve (12) month contract, beginning as soon as possible.

Partial Qualifications:

- Minimum Drinking-Water Operator Certificates: Water Distribution and Supply Subsystem Class 1, and Water Treatment Subsystem Class 1.
- One (1) year of experience in the operation and maintenance of water supply, treatment and distribution
- Must reside in a location not more than thirty (30) minutes driving distance from the Operations Centre in order to be able to respond to alarms and other emergency situations; must be available for, and respond to emergency calls relating to the operation of the water supply, treatment and distribution systems during evenings and weekends in accordance with an on-call rotation schedule.

Compensation: Minimum rate \$30.37 per hour, maximum rate \$39.34 per hour (2022 rates), dependent on the level of OWWCO Water/Wastewater Licenses held by the candidate. Benefit package offered for both positions
